This is for informational purposes only – this is not the actual permit *All septic systems in Burleson County require a permit.*

Before submitting the application

Step 1 A <u>physical address</u> must be issued and/or verified by the Burleson County 911 Addressing office prior to submitting the OSSF application. <u>The address verification letter issued by the 911 Addressing office must be included with the OSSF application.</u> Visit https://www.burlesoncountytx.gov/page/gov.addressing.

Step 2 <u>Choose a Licensed Installer</u> a partial list of licensed professionals is available at https://www.burlesoncountytx.gov/page/gov.environmental. <u>Septic systems must be installed by a licensed installer.</u>

Your appropriately licensed installer may perform OR may contract with a Licensed Site Evaluator, Professional Engineer or Registered Sanitarian to complete the following: **Site & Soil evaluation**, **system selection**, and **system design**. This information is required <u>before</u> submitting the OSSF application.

Step 1 Submit the OSSF application and all required documents to the Environmental Dept. located in the Burleson County Courthouse, 100 W Buck St, Suite 303, Caldwell, TX. Documents must be originals or scanned copies. Burleson

After submitting the application

- **Step 1** Application review and Authorization to Construct: The Designated Representative of Burleson County will review the application and system design. If approved, the Authorization-to-Construct will be issued to the installer indicated on the Technical Information Sheet. The Authorization-to-Construct is required before construction can begin and is valid for one year.
- Step 2 System Construction will be performed by the licensed installer indicated on the Technical Information Sheet.
- **Step 3** Construction Inspection: the installer will notify the Designated Representative of Burleson County when the system construction is completed and the system is ready for inspection.
- **Step 4** <u>License-to-Operate:</u> if the system passes the construction inspection a License-to-Operate will be issued by the Designated Representative of Burleson County. <u>The License-to-Operate is required before the OSSF (septic system) is put into service by the owner.</u>
