BE IT REMEMBERED, That a Regular Hearing of Commissioners Court in and for Burleson County, Texas held in the Regular Meeting place of said Court in the County Courthouse in the City of Caldwell, Texas on the 27th day of October, 2025 at 9:00 o'clock A. M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec and Bobby Urbanosky present and County Clerk- Anna L. Schielack were in attendance when the following business came before Court:

- 1) Judge Keith Schroeder called the meeting to Order with the Pledge to the American and Texas Flags.
- 2) Prayer was given by Pastor Juan Frausto.
- 3) No Public Forum.
- 4) Sheriff's Report – Sheriff Rios reported that the Sheriff's Department has the following openings: 3 jailers and 2 dispatchers. Sheriff Rios also reported that there are 59 inmates in jail. (46 males and 13 females). Shaun Edward with Burleson County Health Resources is trying to get ahead of the government shutdown issues and they are starting a Healthy program in the schools within the County. William Ballard spoke to the Court about the Elections Suit with the Appeals Court is through and over. Mimsey reported taxes will be going out November 5 after the Election. D. J. Oliver reported there is a 2.2% voter turnout with the Constitutional Amendment Election so far.
