M. with Judge Keith Schroeder, Commissioners Dwayne Faust, Vincent Svec, David Hildebrand and Bobby Urbanosky present and County Clerk- Anna L. Schielack were in attendance when the following business came before Court:

Jody Tillery reported during the Burn Ban was 54 reported burns, and he wrote 22 citations. The Burn Ban was lifted on December 1, 2025.
