Further, the affidavits are approved and this Court orders that the same be published on the county website.

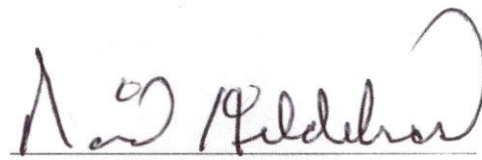

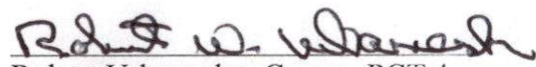
The members of Commissioners Court of Burleson County state as follows:

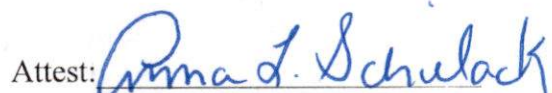
